



Lifetime Limited Warranty

This warranty applies to products manufactured after April 1, 2008.

Length and General Terms of Coverage

WeatherVane Windows LLC ("WeatherVane"), under the conditions and limitations below, warrants all Vantage, Vantage II, and VX Series vinyl windows and doors to be free from manufacturing defects during the lifetime of the original purchaser for so long as they own the property in which the windows or doors were originally installed. For any product proven to be defective and subject to the terms and conditions below, WeatherVane will provide repair or replacement at no charge, including parts and labor required to repair or replace the defective product.

Transferability

In the event of a change in property ownership, this warranty may be transferred to a subsequent owner and will then apply for ten (10) years from the original date of manufacture.

Commercial Applications

Lifetime coverage is provided to individual homeowners only and does not apply to products installed in commercial, rental, or government buildings, such as apartments, offices, motels, or schools or other types of building not used as a residence by the property owner. For purchasers to which lifetime coverage does not apply, the warranty period shall be ten (10) years from the date of installation and shall not be transferable to subsequent owners.

Coverage is not provided for:

- A. Defects, damage or failure caused by improper handling, storage, or faulty installation including windows or doors installed in a non-vertical plane or with inadequate structural support.
- B. Damage from misuse, abuse, impact of foreign objects, acts of God, or by fire, explosion, or other casualty. Misuse shall include use in conditions that exceed product rating or in violation of applicable law and building codes.
- C. Damage caused by failure of purchaser to treat wood surfaces against fungal or insect attack.
- D. Defects or damage caused by air pollution, harmful chemicals, mildew, building settlement, or normal weathering defined as exposure to sunlight and other weather elements that will cause exposed surfaces to gradually fade, stain, or chalk.

Specific Coverage and Limitations

Insulated Glass

Insulated glass is warranted for the lifetime of the original purchaser, subject to all terms herein, against defects that result in material obstruction of view through the glass due to film formation caused by moisture, dust, or low-e coating failure within the airspace (between panes). WeatherVane will replace such defective insulated glass unit at no charge. This warranty does not apply if others have applied a secondary tinted film directly to the glass. Moisture condensation on exposed interior or exterior surfaces of glass, which may result from humidity and other factors, does not indicate defective insulated glass and is not covered by this warranty.

Vinyl

All vinyl components are warranted for the lifetime of the original purchaser, subject to all coverage terms herein, against defects of peeling, flaking, cracking, or blistering. WeatherVane will repair or replace any such defective components at no charge except that products with coatings (paints) applied with authorization from WeatherVane shall be warranted according to the terms and conditions of the WeatherVane Color Coat Limited Warranty (provided separately). No warranty shall apply to vinyl components if they have been painted, stained, or otherwise altered in any way not specifically authorized in writing by WeatherVane.

Hardware and Screens

All locks, rollers, hinges, balancers, fasteners, and other components typically known as "hardware" are warranted for the lifetime of the original purchaser, subject to all coverage terms herein, against the defects of corrosion, breakage, cracking, blistering or peeling. WeatherVane shall repair or replace any such defective components at no charge except that any metal components, when installed within two miles of a seacoast or in any location in the State of Hawaii, shall be warranted against corrosion for only one (1) year from date of original installation.

Screen frames are warranted for the lifetime of the original purchaser, subject to the coverage terms above and excluding screens installed in the State of Hawaii, against the defects of corrosion, cracking, blistering or peeling. WeatherVane will repair or replace any such defective screen at no charge. Screen mesh is specifically excluded from this warranty.

Repair/Replacement Alternative

In lieu of replacement or repair, WeatherVane reserves the right to refund the original purchase price of the defective product and reasonable cost for the original installation as determined by WeatherVane.

Repairs and Replacement Parts

For all repairs or replacements provided under the terms of this warranty, the original warranty shall apply to the repaired or replacement product and will continue for the remainder of the warranty period in effect at the time the product proved defective. WeatherVane reserves the right to modify or discontinue any of its products, including their color, without notice. In the event that WeatherVane modifies or discontinues any product or part, WeatherVane may make repairs or replacement with substitute product or parts determined by WeatherVane to be of comparable quality or price to the originally installed product or part.

WeatherVane shall not be liable for variation in color or gloss of replacement products or parts in comparison to the original product that results from normal weathering.

NO EMPLOYEE, AGENT, REPRESENTATIVE OF WEATHERVANE OR DISTRIBUTOR OF WEATHERVANE IS AUTHORIZED TO MAKE ANY MODIFICATION TO THIS WARRANTY.

Color Coat Limited Warranty

This warranty applies to products manufactured after April 1, 2008.

Length and General Terms of Coverage

WeatherVane Windows LLC ("WeatherVane"), under the conditions and limitations below, warrants for a period of ten (10) years from the date of manufacture that coatings applied to all Vantage I, Vantage II, and VX Series vinyl windows and doors will not crack, pit, peel, blister, or suffer non-uniform fading discoloration. Non-uniform fading discoloration resulting from unequal exposure of surfaces to the sun and elements is specifically excluded from this warranty.

All vinyl components to which coatings are applied are warranted for a period of twenty (20) years from the date of manufacture subject to all coverage terms herein, against the defects of warping, peeling, flaking, cracking, or blistering.

Representations by WeatherVane and this warranty do not include full paint coverage in recesses of vinyl components where voids in coatings may occur or on surfaces determined by WeatherVane to be subject to excessive wear or damage.

This warranty applies only to coatings and coated vinyl components and only when such coatings are specifically authorized by WeatherVane at the time of original manufacture and supersedes warranty coverage for vinyl components provided in the WeatherVane Lifetime Limited Warranty (provided separately). No warranty shall apply to any coatings or vinyl components if they have been painted, stained, or otherwise altered in any way not specifically authorized in writing by WeatherVane.

All other components such as hardware, insulated glass units, screens and non-coated vinyl parts shall be warranted according to the terms and conditions set forth in the WeatherVane Lifetime Limited Warranty.

For any product proven to be defective and subject to the terms and conditions below, WeatherVane will provide repair or replacement at no charge, including parts and labor required to repair or replace the defective product.

Transferability

In the event of a change in property ownership, this warranty may be transferred to a subsequent owner for the remainder of the warranty periods in effect at the time of transfer.

Coverage is not provided for:

- E.** Defects, damage or failure caused by improper handling, storage, or faulty installation.
- F.** Damage from misuse, abuse, impact of foreign objects including windborne debris or sand, air pollution, acts of God, vandalism, or by fire, explosion, or other casualty.
- G.** Defects or damage caused by improper maintenance, including, but not limited to use of or exposure to abrasive cleaning solutions, chemical solvents, masonry or stucco leach, acid washes, caulking, adhesives, paints, or stains and mildew.
- H.** Normal weathering is defined as exposure to sunlight and other weather elements that will cause exposed surfaces to gradually oxidize, fade, stain, or chalk and to do so in varying degrees depending upon amount and intensity of exposure.

Repair/Replacement Alternative

In lieu of replacement or repair, WeatherVane reserves the right to refund the original purchase price of the defective product and reasonable cost for the original installation as determined by WeatherVane.

Repairs and Replacement Parts

For all repairs or replacements provided under the terms of this warranty, the original warranty shall apply to the repaired or replacement product and will continue for the remainder of the warranty periods in effect at the time the product proved defective. WeatherVane reserves the right to modify or

discontinue any of its products, including their color, without notice. In the event WeatherVane modifies or

discontinues any product or part, including certain coating colors, WeatherVane may make repairs or replacement with product or parts determined by WeatherVane to be of comparable quality or price to the originally installed product or part.

WeatherVane shall not be liable for variations in color or gloss of replacement products or parts in comparison to the original product that result from normal weathering.
